 Prices and Terms Of Payment. Unless otherwise specified by PUVI in writing, prices and terms of payment shall be those set forth in the applicable Price Schedule. PUVI reserves the right to change or withdraw prices for the Products or services it offers for sale without prior notice. Partial shipments or performance made within this period will not obligate PUVI to make further shipments or performance at these prices after the expiration of the 30-day period. Checks returned for any reason will be subject to a \$45.00 return fee. NSF check Buyer's will automatically be placed on a prepay cash, credit card or wire transfer purchase requirements, subject to additional fees. Shipments will be held until all funds are received. Prices are in United States dollars payable in Norcross, Georgia, USA unless otherwise specified. Unless otherwise specified by PUVI in writing, all taxes and other charges imposed by federal, state, local, or foreign governments on the manufacturer, sale shipment costs, import, export, or use of the Products or services shall be added to the price and billed to and paid by Buyer. Buyer shall defend, indemnify, and hold harmless PUVI from and against all liabilities for such taxes or charges and attorneys' fees or costs incurred by PUVI in connection therewith.

2.) <u>Available Account Terms.</u> VISA, MasterCard, American Express, Discover Network, Company Checks, Certified or Cashier's Checks, Wire Transfer and Net 30 Credit Terms are acceptable methods of payments and subject to restrictions. All prices are FOB Norcross, GA, and are subject to change without notice. The Buyer will be responsible for all Wire Transfer Fees assessed by the Buyer's bank. Shipment of goods will be held until all funds are received. All funds are payable in US Dollars. No C.O.D.'s

3.) <u>Acceptance.</u> Any Estimate or proposal is subject to change or cancellation by PUVI at any time without notice, and, in any event, expires 14-Days from its date, unless other wise indicted therein or extended in writing by PUVI. PUVI Estimate and proposal does

Accounts more that 20 days past due will be funded with the available credit card on file provided by the Buyer. Future shipments and technical support maybe postponed until credit hold is lifted. Past due amounts will be charged late payment service charges of one and are hold (15%), parcent part part this is in a payment service charges of one and one-half (1.5%) percent per month, which is an annual rate of eighteen (18%) percent. Accounts past due 45+ days may be sent to collections, or small claims court. The Buyer will then be held responsible for all collection fees/court fees, up to 50% of the Past Due

6.) <u>Taxes and Duties.</u> Buyer shall pay, in addition to the purchase price of any product, amounts equal to any tariff, duties and/or sales and use tax or any tax in lieu thereof imposed by any government or governmental agency with respect to the sale of such product(s)

7.) Tax Exemption. Sales tax must be charged to all orders with a location listed in Georgia. Buyers having a current Georgia Resale Form on file with PUVI will be exempt from sales tax. 8.) International Orders. PUVI accepts only wire fund transfers as payment for international orders. Please allow four to six weeks for delivery after receipt of wire transfer. All shipment will be delivered adult signature required, due to the nature of the equipment. All shipments over \$100 will be insured. UPS/FedEx accounts can be used with commercial shipments only. Buyer is responsible for proof of commercial location. If proof cannot be provided, the shipment will be sent as a residential shipment at the buyers expense. Residential shipping accounts (UPS/FedEx) will not be recognized as an available method of payment of shipping expenses. Shipments can only be re-routed by contacting PUVI. Buyer will be responsible for any/all re-routing fees, if applicable.
10. PolarisUSA Video, Inc. Limited Warranty. PUVI warrants merchandise against

defects in material or workmanship for the time frame specified by the original manufacturer from date of purchase unless otherwise stated. Longer and/or broader warranties may be provided by the manufacturer of a particular product. PUVI warranty is limited to the replacement or repair of the defective item at no charge if we determine such item to be defective. Defective items must be shipped prepaid. Buyer is responsible for any/all shipping charges. Items damaged in transport will be returned to the Buyer and all warranty is void. The foregoing remedy is Buyer's only remedy for breach of this limited warranty.
